2. JURISDICTION:

- 2.1. The abovementioned meeting has been authorised by Motorcycling SA Inc which has issued the Motorcycling Australia Permit Number C21707 and is open to holders of current Motorcycling Australia Senior & Junior National Licences, & One Day competition licences.
- 2.2. The meeting will be held in accordance with the current General Competition Rules (GCR's), these Supplementary Regulations, and any final instructions approved by Motorcycling SA Inc.

BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.

3. ENTRIES:

- 3.1. Entries open forthwith and close midnight Friday the 3rd September. Entries will not be accepted on the day. Online entries will be available for this event. More information about online entering will be available at www.mudntars.com, Riders must pre enter for this event using online entries. If you are unable to enter online using ridernet please contact the race secretary. Pony Express riders must organise their own riding partner prior entering the event.
- 3.2. In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the Mud'n'Tars MCC if such retention is approved by Motorcycling SA Inc.
- 3.3. Only entries received on the official entry form that is accompanied by the correct fee will be accepted.

Should there be insufficient entries in any class of competition, the decision to run or cancel the class, or to combine events and re-distribute 10.1. any awards and / or prizemoney, will be at the discretion of the Mud'n'Tars MCC, subject to Motorcycling SA Inc. approval.

11 RACE FORMAT:

Marked natural terrain course of approximately 15 minutes per lap. Competitors to complete the maximum number of laps during the allotted race time. See timetable for race times.

Pony Express teams to "tag" their partner within the marked transition area.

IT IS THE RIDERS RESPONSIBILITY to ensure that the lap scorers have acknowledged and recorded the rider's number for each lap. RIDER NUMBERS WILL BE PROVIDED AT SIGN ON. HELMET NUMBERS WILL BE USED.

Juniors will compete on a modified course & split into 2 races depending on entries and age groups.

12 MACHINES AND RIDERS:

- 12.1 All machines entered must comply with the current GCRs for enduro competition.
- 12.2 Change of machine is not permitted once a race has started.
- Self-scrutineering (senior riders only) Competitors must sign the checklist provided in the final instructions and hand to the chief scrutineer of 12.3 the event. Competitors should refer to section 9.8.0.2 of the MoMs. Helmets are still required to be checked.

13 **GRID POSITIONS:**

Not Applicable

14 **RIDERS' BRIEFING:**

A riders' briefing will be held prior to the commencement of racing, which ALL competitors MUST attend. See timetable for approx times.

Riders Practice: All riders are required to attend a site lap.

15 DRUG AND OR ALCOHOL TESTING:

- 15.1 All competitors and officials are advised that as part of the MA and MSA drug education program, drug testing may take place at any competition in accordance with Australian Sports Commission policy as implemented by the Australian Sports Anti-Doping Authority and the Motorcycling SA Drug and Alcohol Policy.
- If any doubts exist over banned substances it is recommended competitors contact the Drugs in Sport Hotline, tel 1800 020 506. When drug 15.2 testing takes place, the payment of prizemoney may be delayed at the Motorcycling SA Inc. discretion until the results of the tests are known.
- For the purposes of drug and alcohol testing, the commencement of the meeting will be deemed to be 8am with the completion of the meeting 15.3 for the participant being when the participant has vacated the venue.

16 CODE OF CONDUCT:

All competitors, officials and parents are reminded of the Motorcycling Australia by-law - CODE OF CONDUCT (as stipulated in the GCRs), which is a guide to appropriate behaviour at all motorcycle race meetings. This CODE OF CONDUCT applies to this Meeting and will be enforced.

18 CIRCUIT DESCRIPTION:

A marked course of approx 5-10 km's in length, which may consist of natural terrain including rocks, steep accents/descents, creek crossings and scrub.

The course will be marked with arrows and bunting. Anyone found to be intentionally not following the marked course will be asked to withdraw from the event.

19 STARTS:

Start will be waved flag or gunshot, Dead engine, hands on head.

20 RACING:

Competitors will have 1 practice/sighting lap prior to the commencement of their race.

21 NOISE: Changes implemented from 2013

- 21.1 Noise emission levels have been changed: with the 2m max method, the limit is 112 with a 4dB/A allowance
- 21.2 Competitors may be required to undergo a static noise test during the event.
- 21.3 No person may compete in any event on a machine whose emissions exceed the limits as noted in GCR 12.10.1.1
- 21.4 If a machine fails it can be presented for re-testing several times.

22. GST:

The Goods and Services Tax affects the payment of prizemoney. If you do not provide an ABN or declare the sport is a hobby, the Promoter must withhold 48.5% of prizemoney over \$75.00 which is otherwise payable to you. Please tick one of the boxes on the entry form and if appropriate provide your ABN to ensure the full amount of prize money is paid to you.
